The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Alaska, do hereby certify:

1 – Entity Name: The name of the Corporation shall be, God Is Love AK Ministry.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Fairbanks, FNSB (Fairbanks Northstar Borough) County.

2 - Purpose: Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, for the same purposes which this corporation is formed. And, to establish a Christian values-centered Nonprofit organization which will gather and distribute any lawful donations and charitable contributions for lawful use, in accordance with section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, in providing for basic humanitarian aid needs and education, including but not limited to; impoverished, poor, distressed, enslaved, under privileged, or religiously oppressed populations worldwide.

8 - Earnings:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its agents, directors, incorporators, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

9 - Dissolution of the corporation:

Upon the dissolution of the corporation, assets shall be distributed for religious AND charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future state or federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as related to religious AND charitable purposes, which are organized and operated exclusively for such purposes.
